Opioid Updates:

Tobacco/Marijuana/Vaping Updates:

- <u>Tobacco Free Alliance of Virginia</u> (TFAV) updates: There has been a zoning ordinance change around vape shops to limit locations.
- TFAV supports the FDA's proposal to prohibit the sale of menthol cigarettes and flavored cigarettes.
- <u>Virginia Department of Health</u> (VDH) updates: Continuing to develop the Tobacco Use Data Dashboard and the Higher Education Tobacco Policy Report Card Dashboard. Available date: TBD

- Fun and Festive flyer, which promotes finding alternatives for having fun by providing
 mocktail recipes, is now available. Discussed ways to share and disseminate the flyer.
