Meeting Notes: The FPC supports National Suicide Prevention Month and Recovery Month.

Lock & Talk Presentation (Anis Saccoh-Wellness, Health Promotion and Prevention/CSB):

Lock and Talk is a statewide initiative that is aimed at preventing suicide, educating the community about warning signs of suicide, encouraging communication, and connecting with your community to emphasize the safety and prevention around firearms and medications. It promotes wellness, reduces stigma around suicide and saves lives.

The medication Component emphasizes:

- How to safely secure your medications
- How to properly dispose of unused/expired medications
- Taking medications as directed and not sharing medications
- Talking to children about the dangers of overdose with those prescription medications.
- Research shows that students begin to self-medicate around the age of 11 and by age 16, 90% of adolescents report self-administering OTC medications.

The Firearms component emphasizes:

• The safety of securing and/or storing firearms so that it's out of reach of children and loved ones such as: keeping firearms locked with trigger or cable locks.

Key actions: September is National Suicide Prevention month:

- Get help immediately if someone is having thoughts of suicide by calling 911: you can ask for a CIT trained officer (Crisis Intervention Trained).
- Call the National Suicide Prevention Lifeline 988.
- Encourage people to take the CALM class (https://zerosuicide.edc.org/resources/resource-database/counseling-access-lethal-means-calm)
- Inform the community about where to get free lock boxes, trigger locks, cable locks and medication locking caps at 7 locations in Fairfax County. An individual can pick up at the main Prevention office: 7611 Little River Turnpike, suite 200 Annandale, VA.

Recovery Club America Presentation (Gail Embt):

Community Reinforcement and Family Training, CRAFT is an evidenced based program that helps and gives support to families where loved ones are struggling with mental health and/or substance use by providing them with personalized therapy services and peer support services. The focus is on the family as being the most motivated support system. It is designed for parents, siblings, and other family members. The program increases treatment retention and reduces relapse.

CRAFT Goals:

- Engage the loved one in treatment and support
- Reduce the loved one's use of substances
- Improve the quality of life and functioning of the parent, sibling, partner etc.

CRAFT Components:

- Positive communication skills
- Natural consequences
- Healthy boundaries
- Problem solving
- Safety training
- The focus is on the family's own well-being (like training for a marathon)

Recovery Club America has family offerings that are virtual and include:

- 12- week CRAFT training
- Weekly parent support meetings

- Individual and small group coaching
- Workshops
- Online resources
- The cost is \$437 total (\$36 a session), 1 hour a week for 12 weeks that includes homework with applying skills learned in real life.
- Opportunity for scholarships, however, does not take insurance since this is for families.
